

SUBJECT: <u>URGENT REQUEST</u> FOR AN ENACTMENT OF AN ORDINANCE AUTHORIZING THE CITY MAYOR THRU THE CITY LEGAL OFFICE TO FILE A PETITION FOR INTERVENTION IN **SPECIAL CIVIL CASE NO. R-CDO-24-01683-CV** (CAGAYAN DE ORO WATER DISTRICT V. METROPAC WATER INVESTMENT CORP, ET. AL.) AND **SPECIAL CIVIL CASE NO. R-CDO-24-01694-CV** (RONNIE M. WANIWAN, ET. AL. V. CAGAYAN DE ORO BULK WATER INC., ET. AL.) ON GROUNDS OF PARAMOUNT PUBLIC INTEREST.


LADIES AND GENTLEMEN:

This pertains to the recent issues and concerns relating to the conditions of the water supply and distribution in the City of Cagayan de Oro, particularly the conflict between CAGAYAN DE ORO WATER DISTRICT (COWD) and CAGAYAN DE ORO BULK WATER INC. (COBI), which threatened the continued supply and distribution of water in the City of Cagayan de Oro.

As of yesterday, 14 May 2024, we have received information that CAGAYAN DE ORO BULK WATER INC. (COBI) and RIO VERDE WATER CONSORTIUM INC. (RIO VERDE) communicated to CAGAYAN DE ORO WATER DISTRICT (COWD) its decision to cease supplying bulk water by effectively closing the main valves supplying both the east and west pipelines, effective 10:00am.

In view of this development, CAGAYAN DE ORO WATER DISTRICT (COWD) filed a Petition for Injunction with Urgent Application for the Issuance of Temporary Restraining Order (TRO) and/or Writ of Preliminary Injunction against METROPAC WATER INVESTMENTS CORPORATION and CAGAYAN DE ORO BULK WATER INC. which was docketed under **SPECIAL CIVIL CASE NO. R-CDO-24-01683-CV**. Moreover, concerned private citizens RONNIE M. WANIWAN and ENRICO D. SALCEDO filed a similar Petition against CAGAYAN DE ORO BULK WATER INC. (COBI), CAGAYAN DE ORO WATER DISTRICT (COWD), RIO VERDE WATER CONSORTIUM INC. (RIO VERDE) which was also docketed under **SPECIAL CIVIL CASE NO. R-CDO-24-01694-CV**.







Considering that water is a fundamental human need, and that the issue is imbued with public interest, may I humbly request the City Council of Cagayan de Oro to hold a SPECIAL SESSION TO ENACT AN ORDINANCE AUTHORIZING THE CITY MAYOR THRU THE CITY LEGAL OFFICE TO FILE A PETITION FOR INTERVENTION IN SPECIAL CIVIL CASE NO. R-CDO-24-01683-CV (CAGAYAN DE ORO WATER DISTRICT V. METROPAC WATER INVESTMENT CORP, ET. AL.) AND SPECIAL CIVIL CASE NO. R-CDO-24-01694-CV (RONNIE M. WANIWAN, ET. AL. V. CAGAYAN DE ORO BULK WATER INC., ET. AL.) ON GROUNDS OF PARAMOUNT PUBLIC INTEREST.
