of legal age, and hereinafter referred to as the "SCHOOL":

The **CITY GOVERNMENT OF CAGAYAN DE ORO**, a local government unit organized and existing by virtue of its Charter under Republic Act No. 521 and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, with office address at City Hall, Cagayan de Oro City, duly represented herein by its Local Chief Executive, **HON. ROLANDO "KLAREX" A. UY**, hereinafter referred to as the "LGU".

WITNESSETH:

WHEREAS, the SCHOOL, is a private/government institution that offers a Four - Year course, Bachelor of Science in _____, with a permit from Commission on Higher Education (CHED) or Vocational TESDA Courses requiring all its trainees/students to undergo related learning experiences through affiliation training in reputable institutions, ultimately producing globally competitive graduates;

WHEREAS, to attain the objective of the SCHOOL, it wishes to enter into a Memorandum of Agreement (Contract of Affiliation) with the LGU, through the J.R. Borja General Hospital (JRBGH) for the purpose of training their students, wherein the students can have hands-on practice on the principles and theories learned from the classroom to apply it to actual experience in the JRBGH;

WHEREAS, The SCHOOL shall pay the LGU a corresponding amount for affiliation fees based on the standard rates in accordance with Section 582 of Ordinance No. 4373-94 otherwise known as the Codified Ordinance;

WHEREAS, the J.R. BORJA GENERAL HOSPITAL thru the LGU approves the proposal and decision of the SCHOOL to be an affiliate training institution;

NOW, THEREFORE, this Agreement of Affiliation is entered into under the following terms and conditions:

I. OBJECTIVES

- A. To establish a structured and efficient mechanism for the assignment, training, and rotation of _____ students from the SCHOOL to the LGU, ensuring a seamless and effective training experience.
- B. To contribute to the education, training, and professional development of _____ students, preparing them to be globally competitive in their respective fields.

- C. To implement a well-coordinated and functional system for collaboration between the SCHOOL and the LGU, ensuring clear communication and alignment on training activities and objectives.

II. RESPONSIBILITIES OF THE PARTIES

A. JR Borja General Hospital's Responsibilities:

1. To provide maximum opportunity for the affiliate to gain actual experiences and training in the various clinical areas per requirement under the BS Program or Vocational TESDA Courses;
2. To permit the attendance of the trainees in clinical conferences, symposium in specified activities in the professional program of the J.R. Borja General Hospital;
3. To enforce rules and regulations regarding the admission, supervision, training;
4. To reject or refuse the entry, participation, and/or involvement of the persons listed therein if they are unfit, uncooperative or otherwise do not follow or observe its rules and regulations;
5. To provide a copy of the statement of accounts addressed to the Office-In-Charge of the school of the affiliate to prevent the delay of payment of affiliation fee duly certified by the City Treasurer;
6. To conduct and hold regular dialogue with the school affiliating with J.R. Borja General Hospital; and
7. To conduct and hold regular meetings to discuss or deliberate on issues and other concerns relative to training and affiliation activities.

B. Affiliating School's Responsibilities:

1. To submit to the J.R. Borja General Hospital/City Treasurer's Office the certified list of qualified affiliates who will undergo internship training;
2. To assume responsibility for the care of the affiliates in case of illness or injury during the course of affiliation;
3. To reimburse the J.R. Borja General Hospital/City Treasurer's Office in cash or in kind all losses, damages, or breakage caused by act or negligence of any by the interns;
4. To coordinate with the (_____) Division Head or his/her authorized staff on matters concerning the program of internship, training, duties and discipline of affiliates, convocations, and other related activities; and
5. To comply with the existing rules and regulations regarding training and such duties and responsibilities that will be formulated by the LGU may promulgate after the execution of this instrument.

III. EFFECTIVITY

1. This agreement shall be for a term of two (2) years from execution hereof subject to renewal every two years upon such terms conditions as may be mutually agreed upon by the parties; that the LGU has the sole and exclusive prerogative to revise this contract in compliance with such rules and regulations that may be enacted by

the proper authorities provided that the affiliate shall be informed of the modification for compliance.

2. This Contract of Affiliation shall take effect on _____ renewable depending upon the agreement of both parties.

IV. LIABILITY

The SCHOOL shall be solidarily liable for any and all liabilities, damages, loss, injury, and/or death, whether arising from contract, tort (including negligence) or otherwise as a result of the internship herein or should it be the proximate cause thereof.

There shall be no employer-employee relationship between the students and the LGU, and the substituted parental responsibility towards the students shall remain the sole and exclusive responsibility of the SCHOOL.

Except as herein provided, neither party shall assign or transfer all or any of its rights under this Contract without any prior written consent of the party concerned.

The regular court or competent quasi-judicial bodies of Cagayan de Oro City shall have the exclusive jurisdiction over any disputes and/or claims arising hereto.

V. OTHER PROVISIONS

It is expressly understood by the PARTIES that the LGU is not obliged to pay wage or salary since no employer-employee relationship exists between them. However, the LGU is not precluded from providing the student intern any monetary or financial assistance in the form of transportation fee, food, allowance, etc.

All information, data, documents and papers exchanged between LGU - CDO and SCHOOL in relation to the preparation, negotiation and execution of this Contract of Affiliation shall be treated by the Parties with utmost confidentiality and shall not be divulged or shared with any third party, without the prior written consent of either of the Party.

The Parties further acknowledge and agree that for the purposes of this Agreement, each is responsible for compliance with all obligations and duties applicable under the Data Privacy Act of 2012 with respect of any Personal Data which the parties may process in delivery of the Services.
