ORDINANCE NO. 15079-2025

AN ORDINANCE CREATING THE CAGAYAN DE ORO GOLDEN JUSTICE ZONE AND APPROPRIATING FUNDS FOR THE SAID PURPOSE

Whereas, the 20th City Council during its 92nd Regular Session recently passed and approved an ordinance recognizing the need to uphold the rights of children as mandated by various laws, including Section 3(2), Article XV of the 1987 Philippine Constitution, Republic Act No. 7610 (Special Protection of Children Against Abuse, Exploitation, and Discrimination Act), Republic Act No. 11930 (Anti-Online Sexual Abuse or Exploitation of Children (OSAEC) and Anti-Child Sexual Abuse or Exploitation Material (CSAEM) Act), Republic Act No. 9208 (Anti-Trafficking in Persons Act of 2003) as amended by Republic Act No. 10364 (Expanded Anti-Trafficking Act of 2012), and Republic Act No. 11862 (Expanded Anti-Trafficking Act of 2022), which collectively aim to protect children from all forms of abuse, exploitation, and discrimination, and to localize efforts against such crimes;

Whereas, recognizing the increasing risks posed by the internet to children's safety, with 59% of Filipino children accessing the internet unsupervised and significant reports of online sexual abuse, the ordinance supports the need for enhanced local governance, educational programs, and community-based initiatives to combat online sexual abuse and exploitation, improve child protection, and strengthen the city's commitment to child-friendly governance in alignment with the goals outlined in the aforementioned laws;

Whereas, the Justice Sector Coordinating Council (JSCC), comprising the Supreme Court (SC), the Department of Justice (DOJ), and the Department of the Interior and Local Government (DILG), was established to enhance coordination and collaboration among justice sector institutions and address issues affecting the justice system, with the flagship program being the Justice Zone (JZ);

Whereas, last August 7-8, 2024, the Justice Sector Coordinating Council (JSCC) conducted an orientation and consultation meeting and development planning workshop assessing the viability of making Cagayan de Oro City as a Justice Zone as the first one in the country focusing on Anti-online Sexual Abuse and Exploitation of Children (OSAEC) which two-day events were attended by the members of the local judiciary, law enforcement agency such as the NBI and the Philippine National Police, the DILG, the prosecutors from the Department of Justice, from the DSW, CSWD, and other stakeholders;

Whereas, last November 5 to 7, 2024, during the Planning Workshop for the Anti-Online Sexual Abuse or Exploitation of Children (OSAEC) Special Justice Zone in Cagayan de Oro City, participants from various justice sector agencies and stakeholders identified new focus areas—strengthening the delivery of justice at the barangay level, effective case management, addressing jail population concerns, victim protection and support, rehabilitation and reintegration of persons deprived of liberty, law enforcement, and the institutionalization of the Justice Zone—and emphasized that the Justice Zone should address not only OSAEC-related cases but also all forms of sexual abuse and exploitation of children as its overarching goal.

Whereas, a Justice Zone is designed to improve sector efficiency and accountability by promoting coordination among the five pillars of the criminal justice system—law enforcement, prosecution, the courts, corrections, and the community—to deliver swift and fair justice, with a specific focus on resolving problems related to online sexual abuse and exploitation of children (OSAEC) particularly in Cagayan de Oro City;

Whereas, the Philippine Development Plan (PDP) 2023-2028, under Chapter 13, emphasizes the importance of enhancing the administration of justice and institutionalizing Justice Zones across the country to address context-specific justice issues and generate effective, localized solutions;

Whereas, the City of Cagayan de Oro is envisioned to host the first-ever Special Justice Zone focusing on Anti-Online Sexual Abuse and Exploitation of Children, following the successful establishment of similar zones in other cities such as Quezon City, Cebu City, and Zamboanga City;

Whereas, the Justice Zone will serve as a comprehensive approach to combat online sexual abuse and exploitation by implementing targeted prevention programs, improving coordination among justice sector agencies, and enhancing local governance to support and protect victims;

Whereas, under Section 16 of Republic Act No. 7160 (Local Government Code of 1991), local government units are empowered to exercise necessary and appropriate measures for effective governance and the promotion of the general welfare, including enhancing economic prosperity, social justice, and maintaining peace and order;

NOW, THEREFORE:

BE IT ORDAINED by the 20th City Council (*Sangguniang Panlungsod*) of Cagayan de Oro City in session duly assembled that:

SECTION 1. Title - This Ordinance shall be known as an "An Ordinance Adopting the Cagayan de Oro City Golden Justice Zone and Appropriating Funds for the said Purpose", to be known as the "**Golden Justice Zone Ordinance**".

SECTION 2. Declaration of Policy - As it envisioned to be a child-friendly city, it is hereby declared as a policy of Cagayan de Oro City for the formation of the Cagayan de Oro City Golden Justice Zone to address all forms of sexual abuse and exploitation of children including in particular the Online Sexual Abuse and Exploitation of Children (OSAEC) and to advance justice sector coordination of the Justice Sector Coordinating Council (JSCC), which includes the Supreme Court, the Department of Justice (DOJ), and the Department of the Interior and Local Government (DILG). The Justice Zone, as endorsed by the Philippine Development Plan (PDP) 2023-2028, is critical in improving sector efficiency and accountability by fostering collaboration among law enforcement, prosecution, courts, correctional facilities, and community services.

In adopting this policy, Cagayan de Oro City commits to making available its resources to support the JSCC's goal of delivering responsive and real-time justice. This includes the implementation of context-based solutions to justice issues, enhancing coordination among justice sector institutions, and providing technical assistance and equipment support. By establishing the Golden Justice Zone, the city aims to contribute to the broader objectives of justice system efficiency, effective resolution of justice issues, and the safeguarding of children from online and offline exploitation.

SECTION 3. Golden Justice Zone Executive Committee - The Golden Justice Zone shall be convened and led by an Executive Committee (EXECOM), consisting of one (1) Convenor and five (5) Co-Convenors.

The incumbent Executive Judge of the Regional Trial Court of Cagayan de Oro City shall serve as the Convenor. The City Government of Cagayan de Oro, along with the local offices of the Department of Justice (DOJ), the Department of the Interior and Local Government (DILG), and the Department of Social Welfare and Development (DSWD), as well as the local trial courts in the city (Municipal Trial Court or Regional Trial Court), shall each nominate or assign one (1) Co-Convenor. The ExeCom shall oversee and coordinate the plans, initiatives, programs, projects, and activities of the Golden Justice Zone, ensuring alignment with the objectives and priorities of the Justice Sector Coordinating Council.

SECTION 4. Golden Justice Zone Secretariat - The Legislative Support Services Division of the City Council of Cagayan de Oro shall act as the Secretariat performing general administrative and day-to-day management of the ExeCom.

SECTION 5. Golden Justice Zone Technical Working Group - The Technical Working Group of the ExeCom shall be established to assist in conceptualizing and implementing plans, initiatives, programs, projects, and activities. The following specialized Technical Working Groups will be organized for this purpose:

1. Processes and Capacity Building;

2. Evidence Management System;
3. Information Communication Technology and Infrastructure;
4. Sector-wide Planning and Budgeting;
5. Legislative Agenda and Policies;
6. Sector-wide Data Reconciliation, and
7. Communication and Partnership Building.

The ExeCom shall determine the membership of the above-mentioned Technical Working Groups (TWGs) and set their specific responsibilities and deliverables, keeping in mind that all members in the local justice sector should coordinate, communicate, and collaborate.

SECTION 6. High Priority Areas - Subject to amendments or modification which the Justice Sector Coordinating Council may issue, the Golden Justice Zone shall develop and implement plans, projects and programs that are focused on the following:

1. Institutionalization of the Golden Justice Zone
2. Strengthening the Delivery of Justice at the Barangay Level
3. Effective Case Management
4. Jail Population Concerns
5. Victim Protection and Support
6. Rehabilitation and Reintegration of Persons Deprived of Liberty, and
7. Law Enforcement

SECTION 7. Appropriation. – The Justice Zone Executive Committee (ExeCom) shall prepare and submit a proposed budget to the City Mayor for inclusion in the annual appropriations ordinance. The funds approved under this Ordinance shall be managed by the Office of the City Mayor. The ExeCom shall also submit an annual budget plan detailing projects, programs, activities, timelines, and estimated costs. At the end of each year, the ExeCom shall provide an accomplishment report to the City Mayor and the Sangguniang Panlungsod, summarizing the progress and use of the allocated funds.

SECTION 8. Interpretation And Application. - Nothing in this Ordinance shall be interpreted or applied to impair the independence of the Judiciary or to supplant the authority and mandate of any national government agency. In the event of a conflict between this Ordinance, on the one hand, and a national policy, law, regulation or issuance, on the other, the latter will prevail.

SECTION 9. Implementing Rules and Regulation - The City Legal Office and the Justice Sector Coordinating Council shall formulate the implementing rules and regulations within six (6) months upon the approval of this Ordinance.

SECTION 10. Separability Clause - If any provision or part of this Ordinance is held invalid or unconstitutional by a court of law, the remainder of this Ordinance or the provisions not otherwise affected shall remain valid and subsisting.

SECTION 13. Repealing Clause - All ordinances, resolutions, executive orders, memorandum circulars, administrative orders and other issuances or part thereof, which are inconsistent with or contrary to the provisions of this Ordinance, are hereby amended or repealed accordingly.

SECTION 10. Effectivity Clause. - This Ordinance shall take effect after fifteen (15) days following its full publication in a newspaper of general circulation and posting in three (3) conspicuous places in the City of Cagayan de Oro, in accordance with Article 114 of the implementing Rules and Regulations of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

SECTION 1. TITLE

"AN ORDINANCE PERPETUA DECLARING JANUARY 8, 2024 AND EVERY YEAR THEREAFTER AS THE ARAW NG BARANGAY CELEBRATION IN BARANGAY INDAHAG, CAGAYAN DE ORO CITY OF MISAMIS ORIENTAL AND PROVIDING FUNDS OF THIS PURPOSE."

SECTION II. COVERAGE – All ten (10) Sitios: Poblacion, Lomboy, Talisay, Relocation, kamakawan, Sto. Niño, Sumpung, Taguanao, Moloypoloy, and Calacapan; three (3) Subdivisions: Alegria Hills, Bella Vita, Ecoverde; seven (7) Homeowners Association: Habitat Phase 1, Habitat Phase 2, Blessed Ville, Mergeville, Bermundo Village, Balangaw sa Kalinaw Village, Caritas Village.

SECTION III. RATIONALE, PURPOSE AND INTENT OF THE ENACTMENT. The Local Government Unit of Barangay Indahag will undertake various activities during the celebration of barangay day activities to celebrate community engagement, a visible reflection of the Barangay's rich cultural history.

SECTION IV. FUNDING. Funds shall be allocated annually by the barangay to defray the expenses for the conduct of various activities during the celebration.

SECTION V. EFFECTIVITY CLAUSE. – This ordinance takes effect immediately after its approval and publication.

Whereas, each local government unit shall, as far as practicable, evolve a progressive system of taxation;

Whereas, fostering an inclusive and vibrant business environment within Barangay Indahag, Cagayan de Oro City, is paramount for community development and economic prosperity;

Whereas, recognizing the importance of providing equal opportunities for all business owners, regardless of business type or nature of operations;

Whereas, the Indahag Barangay Council aims to promote diversity and inclusivity in the local economy while upholding the principles of fairness and equity;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Barangay of Indahag, Cagayan de Oro City, in session assembled:

Section 1: Definition

For the purpose of this ordinance, the term "business owner" shall refer to any individual, partnership, corporation, or entity engaged in legal commercial activities within the jurisdiction of Barangay Indahag.

Section 2: Equal Opportunity for Business Owners

All business owners, regardless of business type or nature of operations, are hereby allowed to conduct their lawful business activities within Barangay Indahag, without discrimination or preference.

Section 3: Non-Discriminatory Business Regulation

The Barangay Council shall not impose any arbitrary restrictions or discriminatory regulations based on the type of business conducted by owners within Barangay Indahag. All business owners shall be subject to the same set of rules and requirements applicable to their respective businesses.

Section 4: Compliance with Legal Requirements

Business owners shall comply with all relevant local laws, ordinances, and regulations governing their specific type of business activity, including but not limited to health and safety standards, environmental regulations, and taxation requirements.

Section 5: Business Registration and Documentation

All business owners shall register their businesses in the City Government of Cagayan de Oro as mandated in the City Ordinance No. 13992-2020 and submit the necessary documentation as required for record-keeping purposes. Failure to register may result in penalties as prescribed by law.

Section 6: Enforcement and Penalties

Violations of this ordinance shall be subject to penalties as prescribed by existing laws and ordinances. The Barangay Council shall enforce this ordinance and ensure compliance through regular monitoring and inspections.

Section 7: Effectivity

This ordinance shall take effect immediately upon approval and publication in accordance with the relevant laws and regulations.

WHEREAS, under Section 391 of the Republic Act 7160, otherwise known as the Local Government Code of 1991, where the Sangguniang Barangay has powers and duties to enact revenue ordinances and regulate the use of facilities constructed with government funds and charge reasonable fees for the use thereof;

WHEREAS, Barangay Indahag Cagayan de Oro City has 2 covered courts located strategically at Sitio Lomboy and Poblacion;

WHEREAS, the covered courts will serve as a training ground especially for the youths in enhancing their talents in the field of sports and artistic gifts and a venue where residents and non-residents meet together for social and cultural, educational and religious activities;

WHEREAS, to continuously maintain the facilities and covered court expenses the Indahag Barangay Council decided to regulate its usage;

WHEREAS, on motion moved by Barangay Kagawad Augustine R. Laron, Chairman Committee on Finance and duly seconded by the members of the Barangay Council present;

AN ORDINANCE REQUIRING ALL BUSINESS OWNERS AND OPERATORS TO PLACED TRASH CAN OR TRASH BIN IN THEIR ESTABLISHMENTS; ADOPTING SOLID WASTE MANAGEMENT SEGREGATION & IMPOSING NECESSARY PENALTIES FOR VIOLATIONS THEREOF

WHEREAS, Section 48 of Chapter VI of Republic Act 9003 otherwise known as Ecological Solid Waste Management Act of 2000, states that "Littering, Throwing, Dumping, of waste matters in public places like Roads, Sidewalks, Canals, Esteros, or Parks, & Establishments or causing or permitting the same is a prohibited act";

WHEREAS, the same mandate also provides the primary enforcement & responsibility of Solid Waste Management with LGU while establishing a cooperative effort among the national government, Other local government units, NGO's, & the private sectors which may include the row of businesses in the locality who are also considered primary waste generators;

WHEREAS, the Barangay being the lowest local governing body nearest to the people and as provided for in the implementation of its roles and responsibilities vested in the local government code of 1990, It is therefore the duty and obligation of the Barangay to impose significant programs to help the government in its combat against the uncontrolled generation of solid wastes;

WHEREAS, guided by the policy of the nation to protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature as stipulated in section 16 of the 1987 Philippine Constitution, the Barangay has deemed it proper and very necessary to require all business owners and operators to placed trash can or trash bins in their establishment & to properly manage solid wastes generated during their operation by practicing waste segregation, hence the national goal of a zero waste volume of the government may be achieved later in the long run;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED by the Sangguniang Barangay of Indahag in its regular session duly assembled that;

SECTION 1: TITLE

This ordinance shall be known as the **BUSINESS COMMUNITY SOLID WASTE MANAGEMENT OF BARANGAY INDAHAG**.

SECTION 2: DEFINITION OF TERMS

For the purpose of this ordinance, the following terms shall be defined as follows:

- Business Owners and Operators – refers to Sari-Sari Store, Grocery Store, Food Stand, Carenderia and Dry and Wet Market within the barangay.
- Trash Can and Bin - refers to a container used for the temporary storage of waste materials.

SECTION 3: RECOMMENDATION SET-UP

Responsibilities of Business Owners and Operators:

- All business owners and operators within the jurisdiction of Barangay Indahag Cagayan de Oro City are mandated to provide a designated trash bin or trash cans in front of their establishments.
- The trash bins shall be prominently placed and clearly labeled for proper segregation of waste materials such as biodegradable, non-biodegradable, and recyclable items.
- Business Establishments shall be responsible for the regular emptying and proper disposal of waste collected in the provided trash bins.
- Owners and operators shall display visible signage encouraging patrons and passersby to properly dispose of their waste in the designated bins.

Responsibilities of the Barangay:

- Inform all Business Owners and Operators the content of this ordinance.
- The Barangay Captain shall assigned Kagawad Ramil T. Queroyla as the BESWM Focal Person to head the monitoring and implementation of this ordinance to ensure that this ordinance is properly implemented and followed accordingly.
- The focal person shall inspect all businesses in the Barangay.
- Barangay Secretary shall be responsible to paper works and other important documents about this Ordinance.
- Barangay Treasurer – collects fines for any violation of this ordinance as approved by the Sangguniang Barangay.

SECTION 4: PENALTIES

- Business owners and operators found violating the provisions of this ordinance shall be issued a warning for the first offense.
- Subsequent violations shall be penalized with fines as follows:
 - Second Offense: ₱500.00 + 1 week Community Service
 - Third & Subsequent Offense: ₱ 1, 000.00 + 2 weeks Community Service

3. The fines collected shall be allocated for the implementation of solid waste management programs within the jurisdiction.

SECTION 5: REPEALING CLAUSE

This ordinance shall take effect immediately upon the approval of the Barangay Council subject for review of the City Council of Cagayan de Oro.



WHEREAS, noise pollution from motorcycles equipped with open pipe mufflers has become a significant concern for residents of Barangay Indahag, Cagayan de Oro City, disrupting their peace and tranquility;

WHEREAS, noise pollution has adverse effects on physical health, mental well-being, and overall quality of life for residents living in close proximity to noisy areas;

WHEREAS, it is the responsibility of the Barangay Council to enact measures aimed at promoting the health, safety, and welfare of its constituents;

WHEREAS, regulating the use of open pipe mufflers in motorcycles can significantly reduce noise pollution in residential areas;

BE IT ORDAINED by the Sangguniang Barangay of Indahag, Cagayan de Oro City, in session assembled:

SECTION 1: TITLE

This ordinance shall be known as the "Indahag Motorcycle Muffler Regulation Ordinance."

SECTION 2: PURPOSE

1. The Sangguniang Barangay recognizes the need to address noise pollution caused by motorcycles equipped with open pipe mufflers in residential areas of Barangay Indahag.
2. The Barangay Council shall conduct an information campaign to raise awareness among motorcycle owners and residents regarding the adverse effects of noise pollution and the importance of using mufflers that comply with noise regulations.
3. The Barangay Council shall collaborate with relevant authorities, including the Philippine National Police (PNP), to strictly enforce existing noise pollution ordinances and regulations, particularly in residential areas.
4. The Barangay Council shall engage with motorcycle associations and other stakeholders to solicit their cooperation and support in addressing noise pollution issues.

**AN ORDINANCE DECLARING 1ST WEEK OF DECEMBER AS FARMERS
WEEK**

Chairman-Committee on Sanitation & Environmental Protection

Whereas, Republic Act 7607 primarily aims in realizing equitable distribution of benefits and opportunities through the empowerment of the small farmers. The law recognizes the country's responsibility for the welfare and development of small farmers by giving them support in attaining their socioeconomic goals;

Whereas, Farmers have great importance in our society. They are the ones who provide us food to eat;

Whereas, the government has accorded the highest priority to the development of agriculture not only to achieve an equitable distribution of benefits but also to enable the farmers maximize their contribution to the nation's wealth;

Whereas, a Farmers Week should be properly calendared each year for the purpose of giving recognition to the Barangay Farmers for their important role and insurmountable effort that ensures the optimum, balanced and sustainable agricultural development of Barangay Cugman;

Whereas, the Local Government Unit of Barangay Cugman recognizes the role of the farmers sector in the upliftment of agriculture;

Now, Therefore, be it ordained by the Sanguniang Barangay of Cugman, Cagayan de Oro City, during its regular session on that:

SECTION 1. TITLE. This Ordinance shall be known as **"Barangay Cugman Farmers Week Celebration"**

SECTION 2. DECLARATION OF POLICY. The Barangay of Cugman adheres to the principles of sustainable development and promotes self-sufficiency in crops and other prime commodities.

SECTION 3. DEFINITION OF TERMS. Whenever use in this ordinance the following terms be construed to mean as;

1. **Agriculture** — the science, art or practice of cultivating the soil, producer's crops and raising livestock and in varying degrees the preparations and marketing of the resulting products.
2. **Farmer** — (also called agriculture), a person engaged in agriculture, raising living organism for food or raw materials. The term usually applied to people who do some combination of raising field crops, orchards, vineyards, poultry and other livestock.
3. **Farm Animal(s)** – animals that are commonly raised or kept in an agricultural enterprise for purposes of breeding, animal by-products or beasts of burden.

SECTION 4. RATIONALE. The primary goal of this ordinance is to declaring the first (1st) week of December as Farmers Week by acknowledging and recognizing the small farmers of Barangay Cugman in order to express gratitude to them.

SECTION 5. PROGRAM ACTIVITIES. The Farmers Week shall have several programs and activities for the whole week celebration which include, but not limited to, the following:

- a. Showcasing/marketing of farm produce especially those organically and locally grown, hence, there should be no fees or market charges collected as incentives to farmers during the conduct of Agri-Business Trade Fair/Harvest and Farm Festival
- b. Farmers Forum and Achievement Day
- c. Annual Search for the most outstanding farmer/Ginoo and Ginang Magsasaka
- d. Search for Garden sa Bakuran
- e. Gabi ng Magsasaka
- f. Booth Contest

SECTION 6. SEPARABILITY CLAUSE. The provisions of this ordinance are hereby declared to be separable; in the event that one or more of the provisions are held illegal or unconstitutional, the validity of the other provisions shall not be affected.

SECTION 7. EFFECTIVITY CLAUSE - This ordinance shall take effect immediately upon approval.

ELECTED FOR THREE (3) CONSECUTIVE TERMS IN THE SAME
POSITION**

Whereas, Barangay is the smallest political unit of society and considered as the most fundamental organizational building blocks of the country as monolith providing strength and support towards national progress and stability;

Whereas, Barangay Officials are given some benefits provided under the Local Government Code of 1991, such benefits are apparently limited relative to the overwhelming tasks and responsibilities and other mandates that the officials are performing in accordance with existing laws and directives especially in the aspect of maintenance of peace and order and community relations;

Whereas, the Barangay Officials who have rendered services for three (3) consecutive terms of office shall be given an awards and recognition for the public service they have extended as Barangay Officials of Barangay Cugman;

“Be it enacted by the Sangguniang Barangay in session duly assembled:

SECTION 1. TITLE. This Ordinance shall be known as the **“EXEMPLARY PUBLIC SERVICE AWARD”**

SECTION 2. SCOPE AND COVERAGE. Recipients of the award shall be Barangay Officials who have completed three (3) consecutive terms of office as Punong Barangay and Barangay Kagawad respectively. Coverage of the award with respect to the terms of office shall commence in the term of office and subsequently the terms of office thereafter as basis for the qualifications of consecutive terms of office.

SECTION 3. RECOGNITION AND CATEGORIES OF AWARDS. There shall be recognition and categories of the "Exemplary Public Service Award" enumerated as follows:

- I. Categories of recipients of the Award** — Punong Barangay and Barangay Kagawad.
- II. Forms of Award** — (a) A Plaque of Appreciation/Certification of recognition; (b) Exemplary Award Trophy; (c) A cash Award: Punong Barangay – Ten Thousand Pesos (Php10,000.00), Barangay Kagawad – Five Thousand Pesos (Php5,000.00).

SECTION 4. AWARDING CEREMONY. The Exemplary Public Service Award shall be bestowed to the recipients during the Flag Ceremony of the First Monday of the last month of his/her term of the said Barangay Officials.

SECTION 5. QUALIFICATIONS.

- a. The Barangay Council shall create Barangay Award, Screening and Selection Board (BASSB) who shall undertake screening and qualify the recipients of the award;
- b. A Barangay Official who is convicted of any administrative or criminal offense by any government agency, quasi-judicial bodies or courts during his incumbency shall be disqualified to the awards;
- c. In case the first (1st) ranking Barangay Kagawad by operations of law by virtue of Title Two (2), chapter of the Local Government Code of 1991 occupied the position of a Punong Barangay due to permanent vacancy in the position of the latter, the former shall still be qualified to be a recipient under the category of Awards for Barangay Kagawad for which he had equivalently served the unexpired term of his present position as Punong Barangay.

SECTION 6. IMPLEMENTATION.

- a. A Barangay Award, Screening and Selection Board (BASSB) shall be created to be composed of the following: Chairman PUNONG BARANGAY members, three (3) representatives from Barangay Council duly accredited Non-Government Organization.
- b. Functions and Responsibilities: The Barangay Award, Screening and Selection (BASSB) shall have the following functions and responsibilities.
 1. Formulate guidelines for the implementation of this Ordinance.
 2. Devise a monitoring mechanism to examine and determine the records and performance of Barangay Officials in the

- execution of their functions and the quality of Governance and Delivery of service to their respective Barangays; and,
3. Perform such other functions that would redound to the effective implementation of this ordinance.

SECTION 7. FUNDING – The Cash Award is hereby appropriated as initial fund for the awards subject to compliance with existing Commission on Audit (COA) rules and regulations.

SECTION 8. REPEALING CLAUSE – Any ordinance or resolution found inconsistent with this shall be repealed or modified accordingly.

SECTION 9. EFFECTIVITY CLAUSE – This Ordinance shall take effect immediately upon approval.

WHEREAS, Sangguniang Barangay of Cugman has been steadfast in recognizing the successful careers, accomplishments and achievements of its outstanding citizens in their respective chosen field of professions and careers;

WHEREAS, National and International winners of National and International competitions in the following fields of human endeavors to include academic, arts, culture and sports who are native sons or daughters of the Barangay are worthy of recognition;

WHEREAS, an individual or group of individuals who have distinguished themselves by their exemplary achievements in various fields of endeavors cannot be left unrecognized by the Barangay;

WHEREAS, the granting of recognition and incentives to Cugmanon's by the Sangguniang Barangay of Cugman is one way of inspiring them to strive for greater heights of excellence;

WHEREAS, it is also another way of expressing gratitude to these people for the honor and prestige they brought to the Barangay;

WHEREAS, the recognition to be accorded these topnotchers and winners/recognized achievers deserve emulation and therefore worthy of public acknowledgement;

WHEREFORE, on motion of HON. ELMER M. COTIAMCO, duly seconded, it was -

BE IT enacted by the Sangguniang Barangay in session assembled:

SECTION 1. TITLE – This ordinance shall be known as “**AN ORDINANCE INSTITUTIONALIZING THE GRANTING OF RECOGNITION AND INCENTIVES TO CUGMANONS WHO ARE TOPNOTCHERS IN NATIONAL BOARD/BAR EXAMINATIONS AND WINNERS/RECOGNIZED ACHIEVERS IN NATIONAL AND INTERNATIONAL COMPETITIONS AND RECOGNIZED FIELDS OF HUMAN ENDEAVORS AND APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES**”.

SECTION 2. DECLARATION OF POLICY. – The Sangguniang Barangay of Cugman hereby institutionalizes the program of granting recognition and incentives to Cugmanon's who are topnotchers in national board/bar examinations and winners and recognized achievers in national and international competitions and related fields of human endeavor to ensure that the objectives for which it was established shall be achieved.

SECTION 3. This Ordinance shall have the following objectives:

1. The Program shall encourage excellence by giving due recognition to the achievements of topnotchers of national board and bar examinations; and
2. The Sangguniang Barangay shall identify the winning performances of Cugmanon's in the field of prestigious national and international competitions and related human endeavors.

SECTION 4. SCOPE AND COVERAGE. – This ordinance shall include all individuals, pairs and groups who brought honor and prestige to the Barangay in the field of arts/culture, academic/educational and sports competitions including professional licensure examinations given by the Professional Regulatory Commission and the Philippine Bar Examination exclusively administered by the Supreme Court of the Philippines.

SECTION 5. DEFINITION OF TERMS.

1. National and International Competitions – refer to prestigious competitions in academic, arts, culture and sports in national or international fields that are organized by duly recognized national and international government agencies and organizations.
2. Topnotcher – a person who is at the top notch of his/her class or for this purpose, top ten scorers in a bar or board examination conducted by the Civil Service Commission (CSC) or the Bar Council of the Philippines.

3. Bar and Board Examination – given by the Professional Regulatory Commission as well as the bar examination by the Supreme Court.
4. Cugmanon – a native of Barangay Cugman born of native Cugmanon parents or either of his/her parents is a native Cugmanon, a non Cugmanon by blood but a permanent resident of good standing and is a registered voter of the province. He/she must be a good moral character and should not have committed any crime that would bring dishonor to the Barangay.
5. Winner – a person awarded gold, silver or bronze medals or their equivalent recognition or citations in a national or international competition or outstanding in fields of human endeavors.

SECTION 6. CREATION OF A COMMITTEE. – To fully implement the goal of this Program, a Committee shall be created which shall be responsible for formulation of a procedural manual as a guide in the granting of recognition and incentives to grantees.

SECTION 7. AWARDS AND INCENTIVES. – The recipients shall receive the following awards and incentives as follows:

- a. First Placer – Plaque of Appreciations plus Twenty Thousand Pesos (Php20,000.00)
- b. Second Placer - Plaque of Appreciations plus Eighteen Thousand Pesos (Php18,000.00)
- c. Third Placer - Plaque of Appreciations plus Sixteen Thousand Pesos (Php16,000.00)
- d. Fourth Placer - Plaque of Appreciations plus Fourteen Thousand Pesos (Php14,000.00)
- e. Fifth Placer - Plaque of Appreciations plus Twelve Thousand Pesos (Php12,000.00)
- f. Sixth Placer - Plaque of Appreciations plus Ten Thousand Pesos (Php10,000.00)
- g. Seventh Placer - Plaque of Appreciations plus Eight Thousand Pesos (Php8,000.00)
- h. Eighth Placer - Plaque of Appreciations plus Six Thousand Pesos (Php6,000.00)
- i. Ninth Placer - Plaque of Appreciations plus Four Thousand Pesos (Php4,000.00)
- j. Tenth Placer - Plaque of Appreciations plus Two Thousand Pesos (Php2,000.00)

SECTION 8. APPROPRIATIONS – An annual appropriation shall be allocated in the Budget to effectively carry out this Program.

SECTION 9. SEPARABILITY CLAUSE – If for any reason, any section or provision of this Ordinance shall be held to be unconstitutional or invalid by competent authority, such judgement or action shall not affect or impair the other sections or provisions thereof.

SECTION 10. REPEALING CLAUSE – All ordinances, executive orders, rules and regulations, or part thereof, in conflict with, or inconsistent with any provisions of this Ordinance are hereby repealed.

SECTION 11. EFFECTIVITY CLAUSE – This ordinance shall take effect after posting and publication as provided by law.

**A PROPOSED ORDINANCE “Anti- Vandalism Ordinance of 2022”
PROHIBITING THE ACTS OF VANDALISM, IMPOSING PENALTIES FOR
VIOLATIONS THEREOF, AND FOR OTHER PURPOSES**

AUTHORED BY: HON. ELMER M. COTIAMCO
Barangay Kagawad

WHEREAS, vandalism is now rampant in Barangay Cugman;

WHEREAS, many public and private establishments in Barangay Cugman become victims of vandalism where their doors, walls and passageways are filled with drawings and markings;

WHEREAS, there are reported case that even streets historical landmarks, statues of known persons and even vehicles are vandalized;

WHEREAS, tourism being one of the main thrusts of the government, in order to attract more tourist to our Barangay, we must present a beautiful and neat place sans vandalized surrounding.

NOW, THEREFORE, on motion by HON. ELMER M. COTIAMCO duly second by all members present, BE IT ORDAINED by the Sangguniang Barangay, that:

Section 1. TITLE. This ordinance shall be known as “**Anti-Vandalism Ordinance of 2022.**”

Section 2. DEFINITION OF TERMS. For the purpose of this ordinance, the following terms are defined:

1. Act of Vandalism – the willful act that damage or deface property belonging to another person or to the public. Examples of this act are writing, drawing, painting, marking or inscribing on any public or private property, any word, slogan, caricature, drawing, mark, symbol; affixing, posting up or displaying on any public or private property any advertisement, bill or notice, without the consent of the owner of the property.
2. Community Service – refers to any act that is performed for the benefit of the community at large, as punishment for an offense or violation of the law. Cleaning up trash, removing graffiti, planting trees, as building

community playground equipment while under supervision of enhancement officers or personnel, are common tasks performed under this type of arrangement.

3. Private property – property of private ownership, besides the patrimonial property of the State, provinces, cities and municipalities, barangays consist all property belonging to private persons such as houses, walls, buildings, gate, concrete columns and fence, either individually or collectively.
4. Public property – those intended for public use, such as roads, ports, buildings and bridges, and others of similar character, constructed by the State or those which belong to the State, for public service or for the development of the national wealth.
5. Vandalism – the malicious and deliberate defacement of somebody else's property.

Section 3. PROHIBITED ACTS. The following acts are prohibited:

- a. Writing, drawing, painting, marking or inscribing on any public or private property any word, slogan, caricature, drawing, mark, symbol or other acts without the consent of the owner; or
- b. Affixing, posting up or displaying on any public or private property any advertisement, bill or notice without the consent of the owner.

Section 4. The Local Chief Executive hereby deputized the Barangay Tanod, Cugman Police Station (Philippine National Police), the Office of City Social Welfare and Development and the Barangay Officials, in enforcing this ordinance.

Section 5. PENAL PROVISION. Any person who shall commit any of the aforementioned acts of vandalism shall be imposed the following penalties:

- a. For the First Offense, administrative fine of Five Hundred Pesos (P 500.00), plus community service of four (4) hours, and restoration of the property in question to its original state;
- b. For the Second Offense, administrative fine of Eight Hundred Pesos (P 800.00), plus community service of eight (8) hours, and restoration of the property in question to its original state;
- c. For the Third Offense, administrative fine of One Thousand Pesos (P 1,000.00), plus community service of sixteen (16) hours, if the violator is below 15 years old, civil liability shall be shouldered by his/her parents. If the violator is above 15 but below 18 years old, he/she will restore the damaged property to its original state plus he/ she will render community service to the school, if enrolled or to the Barangay where the act of vandalism took place, if not enrolled.

Section 6. Schools are encouraged to include in their Values Education or Edukasyong Pagpapahalaga classes, lessons regarding Vandalism.

Section 7. EDUCATION AND INFORMATION DISSEMINATION. The barangay shall conduct an information and dissemination drive in all schools, 10 zones regarding the anti-vandalism drive of the Barangay.

Section 8. SEPARABILITY CLAUSE. If any provision or part hereof is held invalid or unconstitutional, the reminder of the law or the provision not otherwise affected shall remain valid and subsisting.

Section 9. REPEALING CLAUSE. All ordinances inconsistent with any provision of this ordinance are hereby repealed or modified accordingly.

Section 10. This Ordinance shall take effect thirty (30) days from the date of its approval.

AN ORDINANCE UPHOLDING CLEAN FOOD VENDING IN BARANGAY CUGMAN, CAGAYAN DE ORO CITY AND FOR OTHER PURPOSES

ARTICLE I – NAME OF ORDINANCE

This Ordinance shall be known as **LIMPYONG PAGKAON NGA LAMIAN SA CUGMAN 2022. (LIMPYONG PAKALS ORDINANCE 2022)**

ARTICLE II – LEGAL BASIS

WHEREAS, Article II Sec. 15 of the Constitution Declared Policy. The state shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, PD 856 (Sanitation Code). Sec. 30 a,b,c,d & e (food servicing operations)

WHEREAS, RA 10611 (FOOD SAFETY ACT) Article I Sec. 3 (Objectives) PROTECT the PUBLIC from FOOD BORNE ILNESSES & SANITARY, UNWHOLESOME, MISBRANDED and ADULTARATED FOODS;

WHEREAS, 10536 (MEAT INSPECTION CODE) Sec. 16 (hot meal). The carcass INSPECTED and CONDEMNED, Sec. 17 (a condition wherein carcasses so mark have been INSPECTED and found UNSAFE & UNFIT for HUMAN CONSUMPTION);

WHEREAS, Chapter Sec. 3 (g) of the LOCAL GOVERNMENT CODE recognizes the capabilities of local government units, especially the municipalities and barangays, shall be enhanced by providing them with opportunities to participate actively in the implementation of national programs and projects;

ARTICLE III – DEFINITIONS

- **FOOD VENDORS** – Are persons who are ENGAGED in PROCESSING and SELLING of COOKED FOOD.
- **UTENSILS** – Kitchen equipment's use in HANDLING FOODS and EATING.

- **HOT MEAT** – Are carcass from slaughtered animals **SLAUGHTERED OUTSIDE** the **CITY SLAUGHTER HOUSE** or **SLAUGHTERED** and **INSPECTED** and **MARKED** as **UNFIT** for **HUMAN CONSUMPTION**.
- **CONDEMNED CARCASS** – A meat byproduct slaughtered and inspected by meat inspectors and marked unfit for consumption.
- **SANITARY PERMIT** – A document issued by the City Health Office, affirming good sanitation and food handling.
- **HANDWASHING FACILITY** – A space provided for washing of customer's hand before and after eating in eateries and restaurants.
- **CARCASS** – Meat products derived after slaughter.
- **COMMUNITY SERVICE** – An involuntary service as **PENALTY** of a certain offense as provided in an ordinance.

PRESCRIBED FOOD HANDLING PROTOCOLS

1. Secure Sanitary Permit from the **CITY HEALTH OFFICE** prior to operation.
2. Proper nail cutting.
3. Handwashing before meat cutting, vegetable chopping and mixing of Food ingredients.
4. Wearing of hand gloves in food processing and serving.
5. Wearing of Head nets.
6. Provision of handwashing facility for Dine in customers.
7. Washing of utensils after every usage.
8. Wearing of Facemask of food servers.

REFUSE MANAGEMENT

1. Every Establishment or stalls shall maintain a waste bin/box or any container that separates **BIODEGRADABLE**, **REUSABLE** and **NON-BIODEGRADABLE SOLID WASTE**.

ARTICLE IV – PROHIBITIONS

- a. **NON-WEARING** of hairnet, hand gloves and facemask.
- b. Operating without **SEGREGATED WASTE CONTAINER**.
- c. **BARE HAND PICKING** or **HANDLING** of **FOODS**.
- d. **UTILIZATION** of **HOT** and **CONDEMNED MEATS**.

ARTICLE V – SANCTIONS and PENALTIES

1. **VIOLATION** or **ARTICLE IV a, b & c**
 - First Offense – One (1) day community service
 - Second Offense – Two (2) days community service and penalty of Five Hundred Pesos (Php500.00)
 - Third Offense – Penalty of Five Hundred Pesos (Php500.00) plus three (3) days suspension of operation.

2. VIOLATION of ARTICLE IV section d

- Filing of case to LUPON NG TAGAPAMAYAPA or PENALTIES for VIOLATION of **RA 10636** if found guilty by appropriate court.

ARTICLE VI – ORGANIZING OF FOOD SANITATION TASKFORCE

Taskforce shall be composed of the PUNONG BARANGAY as CHAIRMAN.
Kagawad on HEALTH as VICE-CHAIRPERSON

MEMBERS

It will include the Sanitation Officer, BHWs, Zone Leaders, Barangay Tanods. A REPRESENTATIVE from the FOOD VENDORS shall be INCLUDED.

ARTICLE VII – CONDUCT OF PUBLIC HEARING/IEC

Prior to the approval of this ordinance a **PUBLIC HEARING** shall be conducted. This will be participated by food vendors, eateries and restaurant operators. Representatives from SENIOR CITIZEN, YOUTH, PWD and HOMEOWNERS ASSOCIATION shall be ENCOURAGED.

BARANGAY ORDINANCE NO.02

Series of 2019

AN ORDINANCE PROVIDING FOR THE RULES AND REGULATIONS FOR THE CONTROL AND WELFARE OF ANIMALS, PROVIDING PENALTY FOR VIOLATION THERE OF FOR OTHER PURPOSE.

INTRODUCED BY HON. MILLER J. CAGATIN

BE IT ORDAINED, ORDAINED by the Barangay Council of Cugman Cagayan de Oro in session assembled that:

SECTION 1. - Title - This ordinance shall be known and may be referred to in all proceedings as the Animal Control and Welfare Ordinance.

SECTION 2. - Definition - For the purposes of this Ordinance, the following words and phrases are defined and shall be construed as set out in this section unless it is apparent from the context that a different meaning is intended:

A . "Commercial animal establishment" means any premises whereon or wherein is carried on a business of grooming, buying, selling, bartering, training, renting or boarding of dogs, cats or other animals, wild or domestic, or fowl; shall include but be limited to any pet shop, grooming shop, auction, zoological park, circus, performing animal exhibition, boarding or breeding kennel/cattery or any establishment with the purpose of training, leasing, or selling guard dogs. Shall not include animal hospitals, animal shelters or humane societies, the buying or selling of livestock for dairy purposes, not to dairy establishments, the business activities of a duly licensed veterinary hospital;

B. "Dog" means any animal of the canine family;

C. "Dog license" means the license required to be annually issued for each individual dog or issued every three (3) years for each dogs with multi-year rabies vaccination;

D. "Licensed dog" means any dogs for which the license for the current year has been issued and to which the tag provided for in this Ordinance is properly attached;

E. "Owner" means any person who owns, keeps or harbors an animal for fifteen or more consecutive days except a veterinarian or an operator of a kennel or a pet shop engaged in the regular practice of his business as such;

F. "Dog hobbyist" means and person who owns or keeps, within or adjoining a private residence five or more dogs for personal and noncommercial purposes, which are limited to hunting, tracking, exhibition in dog shows, obedience trials, field trials, dog sledding, or to enhance or perpetuate a given breed, and who has secured a permit for such activity. No permit shall be granted for the purpose of breeding, keeping or training dogs for use in fighting events;

G. Stray Animal means an animal which is set loose, unrestrained, and not under the complete control of its owner, or the charge or in possession thereof, found roaming at-large in public or private places whether fettered or not;

H. Public Place include barangay streets, basketball courts, parks, plazas, and such other places open to the public;

I. Private Place includes privately-owned streets or yards, rice fields or farmlands, or lots owned by an individual other than the owner of the animal.

K. Pamatong shall refer to a system of catching stray animals by means of a net or pukot, loop or tranquilizer gun.

L. "Observation" means the act of keeping animals separated for a period of time to prevent the spread of any infectious disease that they could developing; and

M. "Potentially Dangerous Dog" means any of the following:

(1) Any dog which, when unprovoked on two separate occasions, engages in any behavior that requires a defensive action by any person to prevent bodily injury when the person and the dog are off the property of the owner or keeper of the dog.

(2) Any dog which when unprovoked bites a person causing injury; and

(3) Any dog which when unprovoked has killed, seriously bitten, inflicted injury or otherwise caused injury attacking a domestic animal off the property of the owner or keeper of the dog.

N. "Vicious dog" means any dog which, when unprovoked, in an aggressive manner, inflicts severe injury on, or kills a human being other animal.

SECTION 3. - Prohibition.- No person owner, caretaker of, or having custody of, pig, dog, cat, sheep or goat, horse, carabao, cattle, chicken, duck and other fowls shall allow such animal or animals to go astray and roam in or around gardens, orchards and other lands planted to crops, vegetables, ornamental plants, and on public places, such as but not limited to highways, roads, plazas, basketball courts and parks, or to keep, pasture or tether the same on or near trees and/or ornamental plants along highways, barangay roads, plazas, parks and other public places and on identified tree planting, greening and/or reforestation projects sites of the city Government.

SECTION 4. -Impounding of stray animals- Any pig, dog, cat, sheep or goat, horse, carabao, cattle, chicken, duck and other fowls running at large in any of the areas of the Barangay enumerated in the preceding Section and not under the immediate control and direction of a responsible person shall be seized and impounded.

Any person discovering a stray or apparently lost animal shall report the same to the barangay hall. Any person who apprehends or picks up a stray or lost animal shall report the same to the barangay hall within eight hours thereafter and shall release such animal to the barangay upon demand.

SECTION 5.- Method of catching stray animals- All stray animals shall be seized in a humanely manner or through Pamatong Team of Barangay Cugman.

SECTION 6.- Schedule of Pamatong- The schedule in the conduct of Pamatong in Barangay Cugman will be every Monday and Tuesday of the Month.

A. Redemption of impounded animals. Redemption of an impounded animal by the owner shall be made by exhibiting to the Pound keeper any required license certificate or license tag or other satisfactory proof of ownership and by paying to the treasurer's Office in Barangay. If an animal is sold or released to a person other than the owner, the owner of such animal may, at any time within thirty (30) days after such sale or release, redeem the same from such purchaser or other person by reimbursing him the amount of the purchase price and other expenses incidental to the impounding of the animal; Provided, That no person may redeem an animal under this Ordinance if he was given written notice of such impoundment by the Pound keeper and failed for a period of five (5) days after the mailing of such notice to redeem such animal from impoundment.

B. Prohibition- No pound keeper or animal control officer shall purchase or be interested directly or indirectly in the purchase of any impounded animal.

SECTION 7- Impounding Fee.- There shall be imposed impounding fee and an additional fee for feeding at the rate provided for in the Revenue Code each day or fraction thereof on each of stray animal found running or roaming at large, or fettered in public or private places.

There shall be also charged a catching fee for every stray animal, which amount shall be paid to the person catching or to the barangay when the one catching the same animal is a barangay employee or official, as the case maybe, at the rate provided for in the Revenue Code.

The said fees and charges shall be paid to the Barangay Treasurer prior to the release of the impounded animal to its owner.

CHAPTER III - DOG VACCINATION

SECTION 8.- Anti- Rabies Vaccine.- Every owner of dogs or cats shall have his/her dogs or cats, if three (3) months of age or over, be vaccinated with anti-rabies vaccine. For this purpose, the Barangay may request the City Veterinarian or his authorize representative to conduct a vaccination schedule in Barangay Cugman.

SECTION 9.- Vaccination Stations.- In the implementation of this Ordinance, the Barangay may designate area for Vaccination in every Zone.

SECTION 10.- Vaccination by private veterinary doctors.- Any person who will have **his/her dog or cat immunized by private veterinary doctor shall furnish the Barangay with** the immunization certificate.

SECTION 11.- Observation period of biting dog.- If in the opinion of City Veterinarian or City Health Officer the dog may have been exposed to rabies, or if the bitten person or his guardian shall request it, the dog shall be observed for a period of fourteen days. In the discretion of the City Veterinarian, such observation may be on the premises of the owner or at the City Pound at the owner's expense. In case of stray dogs or in case of dogs whose ownership is not known, such observation shall be at City Pound.

SECTION 12.- Surrender for observation- Reclamation. The owner, upon demand made by the City Veterinarian shall forth with surrender any animal which has bitten a human, and which is suspected of having been exposed to rabies, for supervised observation, and the dog may be reclaimed by the owner when adjudged to be free of rabies.

SECTION 13.- Bite reporting by medical practitioners. It shall be the duty of every physician or other practitioner of medicine to report to the City Health Officer the names and addresses of persons treated for bites inflicted by dogs, together with such other information as will be helpful in rabies control.

SECTION 14.- Licensed veterinarian duty.- It shall be the duty of every licensed veterinarian to humanely kill any dog when observed by him is a rabid dog.

SECTION 15.- Proper disposal of rabid dogs or animals.- No person shall kill or cause to be killed any rabid dog or animal biting a human, except in the defense of life and limb or otherwise as herein provided, nor remove same from the area without written permission for the City Veterinarian.

CHAPTER V- DEPUTIZING BARANGAY OFFICIALS

SECTION 16.- Duties of Barangay.- It shall be the duty of the barangay to:

- A. Conduct an inventory of dogs within their respective barangays by recording the name of the owner, possessor, or custodian of the dog; the age and description of the dog; vaccination status or the date of vaccination, the expiration date of immunity, the kind of vaccine used, and the person or administered the vaccine; the metal tag number, if any; and such other details as the City Veterinarian or the Barangay deem necessary.
- B. Furnish the City Veterinarian with records of dogs and animals registered in the barangay.

SECTION 17.- Fees.- In addition to the vaccination fee imposed by the City, the barangays through and ordinance enacted for the purpose may imposed a service fee therefor inclusive of the cost of the license tag.

Stray animals caught by the barangay shall be turned over to the City Pound for this disposal pursuant to the provisions of this Ordinance.

- (a) Records of forms shall be maintained for a period of one (1) year for any animal sold. Record shall contain the following but are not limited.
 - (i) Animal Description-breed, sex, color, and page.

- (ii) The origin of purchase to include the supplier and the date of receipt.
 - (iii) Medical Record and any required treatment program.
- (b) An annual Commercial Animal Establishment license shall be issued upon successful completion of an inspection and payment of the applicable fee and shall be displayed in a conspicuous place.

CHAPTER VI – RESPONSIBLE PET OWNERSHIP

SECTION 18.- Duties of animal owner.- (a) It shall be duty of every owner of any animal, or anyone having any animal in his possession or custody, to exercise reasonable care and to take all necessary steps and precautions to protect other people, property, and animals from injuries or damage which might result from their animal's behavior, regardless of whether such behavior is motivated by mischievous, playfulness, or ferocity.

- (b) In the event that an owner or keeper of any animal is a minor, the parent or guardian of such minor shall be responsible to ensure that all provisions of these regulations are complied with.
- (c) No animal may be sold or given to a minor without the written consent of the parent or legal guardian.

SECTION 19.- Cruelty.- It shall be a violation of these regulations for any individuals to:

- (a) Abandon an animal;
- (b) Torture, torment, cruelly beat/kill, injure, intentionally mutilate, run down with a vehicle intentionally, overdrive, overload, or otherwise abuse any animal;
- (c) Administer poison to any animal or knowingly place or leave any poisonous or other harmful substance with injure or kill any animal other than vermin;
- (d) Use or permit any animal to be used for the purpose of fighting with any other animal;
- (e) Cause, arrange, or authorize these acts;
- (f) Have charge or custody of an animal and inflict unnecessary suffering or pain upon the animal, or unnecessarily fail to provide the animal

- with nutritious food in sufficient quantity, unnecessary veterinary care, proper drink, air, space, shelter, or protection from the elements;
- (g) In the case of activities in which physical pain may unavoidably be caused to animals, such as medical and scientific activities, food processing, customary and normal veterinary and agriculture husbandry practices, and hunting, "cruelty" means a failure to employ the most humane method reasonably available;
 - (h) Owner or custodian of an animal shall fail to provide the animal with humane care and treatment, sufficient, wholesome and nutritious food; portable water in sufficient quantities; proper air, shelter, space, and protection from the weather; and veterinary care when needed;
 - (i) In the case of farm animals, nothing in this Section may be construed as imposing shelter requirements or standards more stringent than normally accepted husbandry practices; and
 - (j) If a chain, rope, line or other such item, is used to tie an animal, it shall be of sufficient length to safely and humanely allow the animal freedom of movement without becoming entangled with obstructions.

SECTION 20.- Sanitary disposal of dogs feces:

- (a) It shall be unlawful in the Barangay for the owner or person having charge or control of any dog to permit such dog to defecate and to allow the feces to remain upon any public street, sidewalk, pathway, park, pedestrian way, or any public facility; on any school ground; or on any private property not owned or possessed by the owner or person having the charge or control of such dog unless the person shall immediately and securely enclose all feces deposited by the animal in a bag, wrapper, or other container and dispose of it in a sanitary manner.
- (b) Any person who has the charge and control of a dog on any public street, sidewalk, pathway, park, pedestrian way, or any public facility; on any school ground, or any private property now owned or possessed by the owner or person having the charge or control of such dog shall at all times maintain in his possession sufficient suitable wrappers, bags, or container for the purpose of complying with the requirements of this Section. The failure of such person to carry such wrappers, bags, or containers when in charge or control of a dog on any public street, sidewalk, pathway, park, pedestrian way, or any

public facility; on any school ground; or on any private property not owned or possessed by the owner or person having a charge or control of such dog shall constitute a violation this section.

- (c) A sightless person, who has the charge or control of a guide dog, or a Police Dog in the performance of law enforcement duties, shall be exempt from the provisions of this Section.

SECTION 21.- Castration.- Only licensed veterinarians shall undertake the procedure of conducting castration of dogs, cats and other animals pursuant regulation relative thereto.

SECTION 22.- Animals and vehicles:

- (a) No person shall transport or carry on any public highway or public roadway, any dogs in a motor vehicle unless the animal is safely enclosed within the vehicle or protected by a cap or container, cage or other device that will prevent the dog from the falling form, being thrown from, or jumping from, the motor vehicle.
- (b) No person shall leave a dog or any other animal in an unattended vehicle without ventilation or in such a manner as to subject the animal to extreme temperatures, which adversely affect the animal's health or welfare.

SECTION 23.- Animal exhibits.- No person shall operate, conduct or maintain any commercial show, circus, animal exhibition or advertising display or device in which any dog, cat or other animal, wild or domestic, or fowl is used or kept without first informing the City Veterinarian therefor.

SECTION 24.- Nuisance:

- (a) It shall be unlawful to suffer or permit any dog, cat, fowl or other animal to habitually bark, yelp, howl, or create noise in such a manner as to continuously disturb the peace of any person(s) and which would constitute as a public nuisance.
- (b) This section shall not apply to customary animal noises of livestock, horses, or other animals kept or owned for agricultural activities in areas including but not limited to farms, ranches and stables which are zoned or legally permitted for such purposes.
- (c) Upon receipt of a documented complaint affirming that a violation as declared in this section exists, the barangay council may issue an order to the owner of the offending animal directing that such violation be abated. In the event that the owner does not comply

with order, the barangay official may cause the animal to be taken into protective custody.

- (d) An animal may be immediately taken into protective custody with or without receipt of a written complaint if it is determined by the barangay official that the noise it has created cannot be abated or quieted so that it continually disturbs the peace of the complaining person(s). If an animal is caused to be taken into protective custody for a violation of this Section, within twenty-four (24) hours of taking into protective custody the City Veterinarian shall notify the owner or address of any affected owner is unknown, notice shall be given by posting the same in conspicuous public places.

An animal placed under protective custody under this section maybe redeemed by the owner or its keeper provided there is presented to the Pound keeper proof of the owner's identity and any required license certificate or license tag or other satisfactory proof of ownership and by paying the corresponding charges provided for under the Revenue Code. An animal taken into custody under this section may be sold or released by the Pound keeper to a person other than the owner or keeper, if the animal is not redeemed within the period provided under this Ordinance except when the seizing agency or person notifies the Pound keeper that the owner is unavailable due to physical absence or otherwise unable to redeem the animal.

- (e) If the City Veterinarian determines that the animal taken into custody is likely to continue to be in violation of this section upon return to its owner or processor, he/she shall order that the owner or possessor to take such measures as are reasonably necessary to prevent such further violations of this section by the animal, and shall not permit return of the animal to the owner or possessor until such measures have been carried out.

CHAPTER IX – GENERAL PROVISIONS

SECTION 25.- Penalty:

- (a) **Administration fine** – Any person found violating any of the provisions of this Ordinance shall be penalize with the following administrative fines:

(i)	First offense	-	₱500.00
(ii)	Second offense	-	₱800.00
(iii)	Third and subsequent offenses	-	₱1,000.00

(b) Community Service – In case the offender could not pay the administrative fine imposed under this Ordinance, he/she may opt to render community service in lieu of paying the administrative fine at the rate equivalent to eight hours per five Hundred Pesos (P500.00) worth of administrative fine. The community service shall include collection of garbage, cleaning of streets and graffiti, declogging of canals and drains, and other tasks relative to the beautification and clean and green program of the Barangay.

Within seventy-two (72) hours from apprehension, the offender who opt to render community service in lieu of paying administrative fine shall report to the City Veterinarian who shall immediately compute and reflect in a prescribed community service form the required number of hours of community service. The said form shall be duly signed by the City Veterinarian and the offender. The City Veterinarian shall company and entrust the said offender together with the community service form to the City Public Services Officer who shall determine the nature of the required community service as mentioned herein, the location and the specific date and hour when he/she will commence doing community service, which shall be within twenty-four (24) hours from the time he/she reported to the City Veterinarian.

After the apprehended offender completed the required community service, the City Public Services Officer shall issue a certification to this effect. The said Certification shall be submitted to the City Veterinarian to form part of the record of violations of the said offender.

SECTION 26.- Public Officials or Employee.- If the violator is a public officials or employee, aside from the imposable penalty under this Ordinance, the administrative sanctions under the Civil Service Laws, Rules and Regulations may also be imposed.

SECTION 27.- Repealing clause.- The provisions of existing penal or regulatory ordinances which are no longer contained herein or are inconsistent with the provisions of this Ordinance are deemed repealed or amended accordingly.

SECTION 28.- Severability.- If any provision of this Ordinance, or application thereof to any person or circumstances, is held invalid, the validity of the remainder of this Ordinance and the application of such provisions to other persons and circumstances shall not be affected thereby.

SECTION 30.- Effectivity.- This ordinance shall take effect after its publication.

BARANGAY ORDINANCE 016 Series of 2024

AN ORDINANCE REQUIRING THE NUMBERING OF HOUSES IN BARANGAY INDAHAG CAGAYAN DE ORO CITY.

Authored by: Barangay Kagawad Nazar P. Uayan
Co-Authored by: Barangay Kagawad Primo Z. Taglinao

Whereas, the Indahag Barangay Council recognizes the necessity of an organized and systematic approach to property identification within the barangay;

Whereas, the implementation of a comprehensive house numbering system will enhance the efficiency of local governance, emergency services, postal delivery, and various other essential functions;

Whereas, clear and consistent house numbering will contribute positively to public safety, urban planning, and the overall quality of life for residents by facilitating accurate and timely services;

Whereas, on motion moved by Barangay Kagawad Nazar P. Uayan and duly seconded by the members of the Barangay Council present.

BE IT ORDAINED by the Sangguniang Barangay of Indahag, Cagayan de Oro City, in a duly convened meeting, as follows:

SECTION 1. TITLE

This ordinance shall be known as the "**Barangay Indahag House Numbering Ordinance.**"

SECTION 2. PURPOSE

The purpose of this ordinance is to establish a systematic and standardized house numbering scheme within Barangay Indahag to improve basic community services, emergency response, and administrative functions.

SECTION 3. IMPLEMENTATION OF HOUSE NUMBERING

3.1 Mandatory Numbering:

All residential and commercial properties within Barangay Indahag shall be assigned a unique house number. This numbering system shall be implemented in a sequential and logical manner, as determined by the Barangay Council.

3.2 Numbering Format:

The house numbering format shall follow a consistent system, which may include sequential numbers, street names, and/or other identifiers as deemed appropriate by the Barangay Council.

3.3 Responsibility for Installation:

Property owners are responsible for affixing their assigned house number in a visible and legible manner on their property, in compliance with guidelines issued by the Barangay Council.

SECTION 4. BENEFITS OF HOUSE NUMBERING

4.1 Enhanced Emergency Services:

A systematic house numbering scheme will facilitate quicker response times by emergency services, ensuring that help can be dispatched more efficiently to specific locations.

4.2 Improved Postal Services:

Clear and consistent house numbering will enhance the accuracy and reliability of postal delivery, reducing the risk of misdelivered mail and packages.

4.3 Efficient Urban Planning:

Accurate house numbering will assist in better urban planning and infrastructure development, allowing for more effective mapping and resource allocation.

4.4 Administrative Efficiency:

A standardized numbering system will streamline administrative tasks, including tax collection, census-taking, and public service delivery.

SECTION 5. IMPLEMENTATION AND ENFORCEMENT

5.1 Indahag Barangay Council's Role:

The Indahag Barangay Council shall oversee the implementation of this ordinance, including the development and distribution of house numbering guidelines.

5.2 Compliance Monitoring:

The Indahag Barangay Council or its designated representatives shall monitor compliance with this ordinance and provide assistance to property owners as needed.

5.3 Penalties for Non-Compliance:

Property owners who fail to affix their assigned house number within specific time frame after assignment shall be subject to a fine not exceeding P300.00 or other penalties as determined by the Barangay Council.

SECTION 6. FUNDING

The implementation of this ordinance shall be funded through the barangay's budget as identified by the Barangay Council.

SECTION 7. SEPARABILITY CLAUSE

If any provision of this ordinance is declared unconstitutional or invalid, the remaining provisions shall continue to be in full force and effect.

SECTION 8. REPEALING CLAUSE

All ordinances, rules, and regulations or parts thereof that are inconsistent with this ordinance are hereby repealed or modified accordingly.

SECTION 9. EFFECTIVITY

This ordinance shall take effect after its general circulation upon receipt and comments from City Mayor' Office, DILG- CDO and City Legal Office and posting in conspicuous places within Barangay Indahag.



No. 11201 as the primary national government entity responsible for the management, policy, regulation, and program coordination of housing, human settlement, and urban development concerns, is implementing the Pambansang Pabahay Para sa Pilipino (4PH) Program declared through Department Circular No. 2022-004, Series of 2022 as a government housing priority project, in tandem with its Key Shelter Agencies (KSA), which aims to service the housing needs of the Philippines for over six million families by 2028;

WHEREAS, the LGU entered into a Memorandum of Understanding (MOU) with DHSUD dated _____, and agreed to identify land that is suitable and safe for enrolment to the Program, support the mobilization and initiatives of associations of informal settler families who belong to the landless/homeless and underprivileged sector of society, allow, recognize and endorse the participation of contractors and developers to DHSUD, and support the development of housing units under the 4PH Program;

WHEREAS, the HOA, a duly registered Homeowners' Association composed of informal settler families who belong to homeless and underprivileged sector of society, have initiated and mobilized to avail of the Pambansang Pabahay Para sa Pilipino (4PH) Program, for the development and construction of an Off-Site Socialized Residential Condominium for its member-beneficiaries, to be called the **Klarexville XVIII Hillsview Homeowners' Association Incorporated**, in the parcel/s of land situated in Brgy Lumbia, Cagayan de Oro City, Province of Misamis Oriental, Island of Mindanao, covered by TCT No/s. 137-2022004896, totaling to an area of Fifty-Three Thousand Six Hundred Twenty-Nine Square Meters (53,629 sq.m.);

WHEREAS, the LGU supported the mobilization of the HOA and caused its registration with DHSUD and the accreditation of the Klarexville XVIII Hillsview Homeowners' Association Incorporated Off-site Relocation Project;

WHEREAS, the **HOA** requested the help of the **CONTRACTOR/DEVELOPER** in the acquisition of the above-mentioned parcel/s of land, which the latter willingly agreed to facilitate and provide;

WHEREAS, the **HOA** forged an Agreement with the **CONTRACTOR/DEVELOPER**, and recommended the same to the **LGU**, to implement the conceptualization, design, land development and housing construction of the Proposed Klarexville XVIII Hillsvieview Homeowners' Association Incorporated;

WHEREAS, the **CONTRACTOR/DEVELOPER** along with their affiliates, have signified their willingness to participate in the 4PH Program to implement the conceptualization, design, land development and housing construction of the Proposed Klarexville XVIII Hillsvieview Homeowners' Association Incorporated through direct participation and which shall be commensurately credited as present and future compliance of their main projects;

WHEREAS, the **LGU** and **CONTRACTOR/DEVELOPER** have expressed their willingness to complement each other and jointly pursue the objectives of the 4PH Program, whereby the **CONTRACTOR/DEVELOPER** shall provide the necessary land and housing development on the land acquired and owned by the **HOA** for the implementation of a housing project for target member-beneficiaries;

NOW, THEREFORE, for and in consideration of the foregoing premises, the Parties have agreed as follows:

1. REPRESENTATIONS, WARRANTIES AND RESPONSIBILITIES OF THE HOA

1.1. Representation and Warranties. The **HOA** hereby represents and warrants that:

- 1.1.1. It is duly organized, validity existing, and in good standing under the laws of the Republic of the Philippines, and it has the full power, authority, and legal right to execute this Agreement, to exercise their rights and perform their obligations hereunder, and to consummate the transactions contemplated herein;
- 1.1.2. The execution, delivery, and performance by them of this Agreement do not and will not violate any provision of applicable law, or constitute a breach of any contract to which they may be bound;
- 1.1.3. It shall coordinate the project with the **LGU**, to ascertain and certify the viability and suitability of the development site and the corresponding housing needs;
- 1.1.4. It shall coordinate with the **LGU** to ascertain the qualification of the member-beneficiaries that they belong to the informal settler families in the locality of the Off-Site Relocation Project, and for the strengthening of its capacities in the validation of the qualification of member-beneficiaries, and in its capacity to manage its association, enter into a Real Estate Mortgage Agreement or a development loan with KSAs and/or Government Financial Institutions (GFIs), enter into and execute the necessary document covering the conveyance of the housing units to the member beneficiaries; and
- 1.1.5. To ensure the implementation and completion of the development and construction of the Off-site Socialized Residential Condominium, it shall recommend to the Local Chief Executive of the **LGU** the **CONTRACTOR/ DEVELOPER**, for monitoring and compliance with applicable government rules and regulations.

1.2. Obligations of the HOA

- 1.2.1. **Subsequent Agreements.** It shall execute a Development and Construction Agreement with the **CONTRACTOR/DEVELOPER** detailing the scope of works, technical specifications, and work schedules, that will be complied with in the site development and construction;
- 1.2.2. **Financing.** It shall apply for development loan with the **Socialized Housing Finance Corporation (SHFC)**, the lead government agency mandated, under E.O. 272, to undertake social housing programs for the formal and informal sectors in the low-income bracket;
- 1.2.3. It shall execute a Deed of Assignment of loan proceeds in favor of the **CONTRACTOR/DEVELOPER** and shall submit the same to SHFC prior to the release of the site development and construction loan. Upon review and validation of submitted requirements by SHFC, it shall request for the initial release of the loan equivalent to Fifteen Percent (15%) of the loan for site development and construction, and the subsequent releases which shall be made in progress billing in a maximum of five (5) tranches; and
- 1.2.4. Upon project completion and turn-over of the Klarexville XVIII Hillview Homeowners' Association Incorporated by **CONTRACTOR/DEVELOPER** to the **HOA** and SHFC, it shall issue a Certificate of Completion and Acceptance, which shall also be validated and reviewed by SHFC, and shall request for the release of the final payment for the completion of the project.

2. REPRESENTATIONS, WARRANTIES AND RESPONSIBILITIES OF THE LGU

2.1. **Representations and Warranties.** The LGU hereby represents and warrants that:

- 2.1.1. It has the full power, authority, and legal right to execute this Agreement and the Deed/s, to exercise its rights and perform its obligations hereunder, and to consummate the transactions contemplated herein;
- 2.1.2. The execution, delivery and performance by it of this Agreement of the Deed/s do not and will not violate any provision of applicable law or constitute a breach of any contract to which it is a party or by which it may be bound;
- 2.1.3. It shall comply with all applicable laws, rules, and regulation, issuances and order of relevant government agencies in the performance of its obligations under this Agreement and the Deed/s, including any future construction or development activities therein;
- 2.1.4. All consents necessary for the due execution, delivery, and performance of this Agreement and Deed/s have been obtained;
- 2.1.5. It shall ascertain and provide clearance for the ownership of the **HOA** over the property or parcel/s of land where the Off-Site Relocation Project will be developed, located in Bgy Lumbia, Cagayan de Oro City, Province of Misamis Oriental, Island of Mindanao, all registered with the Registry of Deeds of Cagayan de Oro City;
- 2.1.6. It shall provide support to the initiatives and activities of the **HOA** in compliance with the guidelines set forth for the 4PH Program;
- 2.1.7. It shall allow, recognize, permit and endorse the **CONTRACTOR/DEVELOPER's** participation in the Project as agreed by and between the **HOA** and the **CONTRACTOR/DEVELOPER**;

- 2.1.8. It shall permit the **CONTRACTOR/DEVELOPER** to primarily manage the execution of the land and housing developments of the Project, in coordination with the **HOA**, which shall include but not be limited to:
- 2.1.8.1. Planning and design of land development and its engineering components;
 - 2.1.8.2. Constructing the condominium with 1,860 units;
 - 2.1.8.3. Procuring and appointing of contractors/subcontractors;
 - 2.1.8.4. Managing the financing for the Project;
 - 2.1.8.5. Managing and monitoring the day-to-day development activities, including the timetable, safety and quality control; and
 - 2.1.8.6. Turning over of completed land and housing developments.

2.2. **Obligations of the LGU:**

- 2.2.1. **Capacity Building of HOA.** It shall facilitate the development and strengthening of the capacities of the **HOA** in the validation of the qualification of member-beneficiaries, and in its capacity to manage its association, enter into a Real Estate Mortgage Agreement or a development loan with KSAs and/or Government Financial Institutions (GFIs), enter into and execute the necessary document covering the conveyance of the housing units to the member beneficiaries;
- 2.2.2. **Technical Assistance.** It is obligated to provide technical assistance to the parties involved in the development and construction project. This may include support in areas such as engineering, architecture, urban planning, and project management to ensure the successful implementation of the housing project.
- 2.2.3. **Legal Assistance.** It is responsible for providing legal assistance to facilitate the execution of the project. This assistance may involve legal advice, drafting of legal documents, and representation in legal proceedings related to the housing development project. It aims to ensure compliance with relevant laws, regulations, and contractual agreements.
- 2.2.4. **Identification of Borrowers.** It is tasked with identifying potential borrowers who meet the qualifications set by the city for participation in the housing project. This involves assessing the eligibility criteria for borrowers, verifying their qualifications, and ensuring compliance with the requirements for obtaining financing for the project. The LGU plays a crucial role in facilitating access to financial resources for eligible beneficiaries of the housing project.
- 2.2.5. **Development and Construction Permits and Licenses.** It shall promptly provide or cause to provide the necessary development, construction and building permits from the LGU needed in the implementation and completion of the Proposed project.

3. REPRESENTATIONS, WARRANTIES, AND RIGHTS AND OBLIGATIONS OF THE DEVELOPER

3.1. **Representations and Warranties.** The **CONTRACTOR/DEVELOPER** hereby represents and warrants that:

- 3.1.1. It is duly organized, validity existing, and in good standing under the laws of the Republic of the Philippines;
- 3.1.2. It has the full power, authority, and legal right to execute this Agreement, to exercise their rights and perform their obligations hereunder, and to consummate the transactions contemplated herein;
- 3.1.3. The execution, delivery, and performance by them of this Agreement do not and will not violate any provision of applicable law, or constitute a breach of any contract to which they may be bound;
- 3.1.4. It shall cause its Contractors/Sub-Contractors to agree to account for all defects in the land and housing development and warrant that the Project shall be developed and contemplated in accordance with the development plans approved by the regulatory bodies and the concerned parties;
- 3.1.5. All consents necessary for the due execution, delivery and performance of this Agreement have been obtained; and
- 3.1.6. The obligations expressed to be assumed by it under this MOA are, under the laws of the Republic of the Philippines, legal, valid, and binding obligations, enforceable against them in accordance with the terms and conditions hereof, and that all acts, conditions, and things required by their Articles of Incorporation to be done, fulfilled, or performed in order to enable it to enter into, execute, deliver, exercise its rights, and perform its obligations hereunder stated.

3.2. Obligations of the **CONTRACTOR/DEVELOPER**

- 3.2.1. **Subsequent Agreements.** It shall execute the necessary Deed/s with the **HOA**, laying down the terms and conditions of the land development and housing construction, which may be done in phases, and on which the Project shall be established and registered by the latter with the relevant national and local government agencies.
- 3.2.2. **Conceptualization, Planning and Design.** It shall conceptualize, plan and design, in agreement with the **HOA**, the proposed 15 Storey Klarexville XVIII Hillsvieview Homeowners' Association Incorporated with 1,860 units.
- 3.2.3. **Permits and Licenses.** It shall ensure that all the necessary permits and bonds, such as but not limited to environmental clearances, development and building permits, performance and or surety bonds are secured from the proper authorities.

- 3.2.5. **Financing.** It shall provide support to the **HOA** in securing the funding for the proposed 15 Storey Klarexville XVIII Hillsvieview Homeowners' Association Incorporated, including the land development and building construction from GFIs

enrolled in the Program consistent with the standards of DHSUD under the Program and other concerned regulatory agencies;

- 3.2.6. **Loan Documentation.** It shall ensure that all necessary loan documentation is accurately prepared and submitted to the appropriate authorities, including the Socialized Housing Finance Corporation (SHFC), in compliance with their requirements. This involves gathering and verifying the qualifications and documents of each borrower to ensure they comply with SHFC's regulations and guidelines for loan approval. Additionally, the contractor/developer shall oversee the execution of the Deed of Assignment of loan proceeds in favor of the contractor/developer and coordinate with SHFC for the release of the loan proceeds for site development and construction.

4. FREE AND HARMLESS CLAUSE

- 4.1. The **CONTRACTOR/DEVELOPER** shall hold the **LGU** and its officials and personnel free and harmless from any and all claims, actions, liabilities, losses, and suits which may be brought or instituted by any party whatsoever by reason of the fault, failure, negligence, delay, or any conduct on its part or that of its Contractor/Sub-Contractors, its respective officers, employees, and agents in the performance of their corresponding obligations under this Agreement, without prejudice to its claim against the proper erring party;
- 4.2. The **CONTRACTOR/DEVELOPER** and/or their Affiliated including their directors, officers, employees, agents and representatives, shall be free and harmless from and against any and all claims, demands, actions, suits, damages payable to third parties by reason of any delays in the enforcement of the Project or failure of the LGU to fully support the Project, unless such is caused by the fault, negligence, or willful misconduct of the **CONTRACTOR/DEVELOPER** or its representatives in the fulfillment of its obligations as specified under this Agreement.
